Bids for Culvert replacement were opened. Two Bids were received: Snowman's Construction for \$23,000 and B&C Sand & Gravel, Inc. for \$55,000

Dave made a motion to award contract to Snowman's, Herb second. Some discussion on thickness of pavement. Vote - AIF

<u>Public Access</u>: Pat would like to stake out Walking Trail in the Town Park, Board gave it's support.

Reports:

<u>Public Works</u> – Sheldon asked about request concerning driveways on South Ridge Road. MMA recommends taking care of issue with drop from raising road. Towns' responsibility depends on Deed to Road describing width. Received information on Gale Road from SW Cole. Finding confirmed the need to dig out road put down fabric and replace with better materials. Snowman's said they would honor price from earlier quote. Dave made a motion to accept quote from Snowman's w/ addition of Fabric and Culverts which the Town will provide, Herb second. AIF Darge will provide Winter Sand for same price as last year (\$12 per Yard). Question on road side mowing. Herb is working on it in between showers, doesn't mow well when wet. Sheldon had figures on gravel for the Smith Road. With other projects may not have funds to do complete length of road.

 Dave made a motion to spend up to \$2000 to purchase a Tower, Herb second. Will have to wait till one is available. Vote AIF
- ➤ Board wants all members to have keys to the office.
- Need to contact Unifirst about picking up mop heads to clean.
- ➤ Jo-Ann made a motion to pay for repairs to 05 International, Dave second. Truck is at Wentworth's for approximately \$4000 of repairs. Discussion on what to do with truck, sell or have for backup? Possibly have article in warrant for Special Town Meeting so to be able to sell truck and apply funds to Public Works account.
