### Reports:

<u>Planning Board</u> – Minutes Submitted, Dave Leavitt updated Board on Planning Board activities. Hearing was held on Ordinance amendment for Town Meeting, no input. Adjustments will be made to the Warrant. Needs to be sent to the printers for the Annual Report tomorrow (the 15<sup>th</sup>). Warrant to be officially accepted and signed at next meeting.

- ➤ Herb made a motion to issue a Quit Claim Deed to Elizabeth Martin and Arlo McDougal for property at 404 Madawaska Road, Jo-Ann second. Delinquent taxes have been paid in full. Vote AIF
- ➤ Dave made a motion to allow Maine Assessment & Appraisal Services to defend against Dean Cray at the County Commissioners on the Boards behalf, Vondell second. Dean has applied for an appeal of abatement of property taxes denial. Vote AIF
- ➤ Board agreed to advertise for Animal Control position.
- ➤ Board agreed to continue with Bolsters for curbside trash pickup. Rates are comparable to what we have been paying and much less than other company that sent a quote for services. Contract will be prepared for next meeting.
- ➤ Motion by Dave to increase Diane's wage by \$2 per hour, Herb second. To be effective on anniversary. AIF
