Administrative Assistant/Treasurer - Treasurers statement to date submitted. Need 2 Board Members to sign Warrants on off weeks. Mike and Herb volunteered. There will be an Elected Officials Workshop on April 1<sup>st</sup> in person or via Zoom for anyone interested. Diane needs a Board Member to sign Concealed Weapons Permits.
