Reports:

Public Works – Pot Holes on paved roads have been patched. Beaver problem on Spring Hill Road. Pat White has cleaned out culverts a few times with his excavator. Mike asked if Pat could be reimbursed for fuel. Herb has been alternating work between 2 part-time employees. Intersections need sweeping. Pot Holes are back on the Smith Road.

Code Enforcement Officer (CEO) – Report Submitted – Information received from BD Solar in response to letter on issues of compliance.

Sexton/Cemeteries – Vondell had more information on Tree Removal

Planning Board – Minutes Submitted – Gail Jones asked the Board about thoughts on Cluster Housing. Issue may need to be addressed in our Ordinances.

Administrative Assistant/Treasurer – Sewer Pipe in the Boiler room needs to be replaced. Gilman's Plumbing plans to do repair this week.
